## **Extract from the HMCCQ Constitution regarding members' register and privacy issues.**

### ***Register of members***

#### ***Required details***

- 1.1 *The management committee must keep a register of members that includes the following particulars of each member:*
- *Full name and last known address.*
  - *The date of admission as a member.*
  - *Any other particulars the management committee or the members at an AGM decide.*
- 1.1.1 *The register must not contain reasons for the death, resignation, termination or re-instatement of any member or former member.*
- 1.1.2 *The register must be open for inspection at all reasonable times. However, before a member may inspect the register, the member must apply to the secretary to inspect it.*
- 1.1.3 *Each member must not use any information contained in that register for any prohibited purpose under any privacy legislation that applies to the register.*
