

## Steps to obtain Special Interest Vehicle (Club) Registration for your motorcycle

1. You must be a member of a recognized Club e.g. HMCCQ.
  - a. Download a Club Membership Application Form from the front page of our website [www.historicmotorcycle.org.au](http://www.historicmotorcycle.org.au) .
  - b. You will need to have your Application proposed and seconded by current members of the Club.
  - c. Choose the Club Area nearest you and contact that Area Secretary for assistance. The Area Contact page on our website lists contact details.
2. You will need to present your Club Identification Card as proof of your membership at Department of Transport and Main Roads (TMR). The membership card can take 6 weeks to arrive after applying for membership.
3. Your motorcycle must be at least 30 years old to be eligible. Details are on our website Dating page.
4. Download and complete 3 copies of our *Queensland Special Interest Vehicle Scheme Historic Dating Certificate* from the website. Follow the instructions on the form.
5. Contact your Area Secretary for the name etc of your HMCCQ Area Inspection officer. The Area Contact page on our website lists contact details for your Area Secretary.
  - a. The Area Dating Officer will arrange to inspect the bike and confirm the information on the forms.
  - b. Follow the instructions on the form.
6. Arrange for optional Comprehensive Insurance of your bike pending its registration.
7. You may choose to arrange your Compulsory Third Party Insurance before visiting the TMR, but it is available across the counter at the time of Registration. If the bike has both insurances in place, you can apply to TMR for permission to ride the bike from your home to the Road Worthy Inspection Station and to the TMR registration office for the purposes of registration. Otherwise you will need to trailer the bike to both.
8. Obtain a Road Worthy Inspection Certificate from any registered motorcycle Inspector.
9. If you were the registered owner of the bike when it was previously registered, the TMR may not need to sight the bike at the time of registration. If this applies in your case, phone your local TMR office first to confirm. Otherwise you will need to present your bike for them to inspect the serial numbers at the time of registration.
10. Fill out the TMR Registration Concession Application (form F3937). It is available at [www.support.transport.qld.gov.au/qt/formsdat.nsf/Forms/QF3937](http://www.support.transport.qld.gov.au/qt/formsdat.nsf/Forms/QF3937)
11. Gather together:
  - a. Roadworthy Inspection Certificate,
  - b. the completed HMCCQ Historic Dating Certificate
  - c. Club Membership ID Card,
  - d. bike ownership proof – receipt or previous Registration Papers,
  - e. your Driver's Licence and money,
  - f. a completed Queensland Transport Registration Concession Application (form F3937), and
  - g. the bike if the serial numbers need to be checked.
12. Contact your Insurance providers and give them your new registration details.
